# Terms and Conditions of Membership

Members of Southampton Hockey Club ('SHC' or 'the Club') are required to be in agreement to the Terms and Conditions of Membership ('the policy').

## **DATA USAGE**

For all members, including junior members, personal data will be held on a third party server used by Teamo Ltd. SHC take no responsibility for any breach in data confidentiality by Teamo Ltd or any of their providers.

For all members, including junior members, personal data may be accessed by any of the SHC Committee and Team Captains, as detailed below. Access is required so that authorised persons may contact players (or parents if it is a Junior) or access Medical or Next of Kin data.

Access to the database is strictly monitored by the Chairman and Committee members and is regularly reviewed.

Those with access to the SHC membership data base must only use the data for the purposes of hockey correspondence and must not misuse the data. Misuse of data will result in expulsion from the Hockey Club as determined by the Committee.

Access to the Membership Database:

Chairman; Vice Chairman; Director of Coaching; Treasurer; Vice Treasurer; Club Captain; Vice Club Captain; Team Captains; Junior Coaches responsible for each team.

## **MEDICAL INFORMATION & CONSENT**

In case of emergency and as part of the Club's responsibility to its membership, ALL club members are required to complete the medical information section of the Membership Form on the club's website. Details will be held securely as outlines in the above Data Usage Section.

By becoming a Member of Southampton Hockey Club you consider yourself to be physically fit and capable of full participation and agree to notify the Club of any changes to the medical information you previously provided. Furthermore, in the event that you are injured or fall ill, the team managers/coaches appointed by the Club will obtain emergency medical treatment on your behalf.

## **TERMS & CONDITIONS SPECIFIC FOR UNDER 18'S:**

It is a requirement of the Club policy that parental consent is provided for participation, transport and photography. Southampton Hockey Club's Code of Conduct for Coaches, Players, Parents and Spectators, together with the Club's Safeguarding and Protecting Young People in Hockey Policy are published on the Club's website.

## **PHOTOGRAPHY**

In some environments, particularly adult competition, it is impossible to control photography by external parties. However, you should be aware that there may be times that photographs and/or footage may be taken during matches and training sessions by approved agents and/or officers of Southampton Hockey Club. Such images shall only be used for publicity/training purposes in accordance with the Southampton Hockey Club Safeguarding and Protecting Young People in Hockey Policy and Photography Policy. Parents

wishing for their children to be members of Southampton Hockey Club give consent for their son/daughter to feature in such photos/images and give permission for granted approved agents the right to use the images resulting from the photo/film shoots. This includes any reproduction or adaptations of the images for all general purposes i.e. local newspapers, local magazines, other promotional articles (inc. flyers) and the Club's website.

**TRANSPORTATION**

For your son/daughter to become a member of SHC you consent to your son/daughter travelling to venues for matches and training by transport provided by the Club which may include travelling in other players' or parents' private cars.
